Sub: Intimation of sale of Secured Asset under Private Treaty of SARFAESI Act 2002.

Sir/Madam,

- 1. The bank has issued to you Demand Notices dated 22.09.2021 bearing reference No. KNSB/SARFAESI/CC-1200053 & LNPSOD- 1200002/AWARD /177/ 2021-22 under Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 20022.
- 2. According to said Demand Notice you were required to discharge in full liabilities of Rs. 9,49,37,616.32 (Rupees Nine Crore Forty Nine Lakhs Thirty Seven Thousand and Six Hundred Sixteen & Paise Thirty Two Only) as on 31/08/2021 to the bank within 60 days from the date of the notice. The period of 60 days are completed and you have failed to fully discharge the liabilities to the bank.
- 3. Since, failure of non-repayment on your part forced the bank to take the possession of the following secured property.
- 4. The Public Auctions were called for the Sale of the securities on 29.11.2022, 05.01.2023, 10.02.2023 &12.08.2024. However, all the auctions have been failed for the want of bidders. Therefore the property is put on for sale under Private Treaty of the SARFAESI Act 2002 2002 at the Revised Reserve Price of Rs.89.75 Lakhs. The notice to that effect has been pasted on the door of the security on 05.09.2024.
